**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of July 16, 2015, by THE PRIVATEBANK AND TRUST COMPANY (“Lender”), in favor of INNOVATIVE BREWING, LLC, a Delaware limited liability company (“Grantor”).

**WITNESSETH:**

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of March 2, 2015 made by Grantor in favor of Lender (as amended, restated, modified or supplemented and in effect from time to time, the “Security Agreement”) and in order to secure certain debts and obligations owing from Grantor to Lender, Grantor granted a security interest to Lender in, and a lien upon, (i) Grantor’s entire right, title and interest in and to all of its now owned or existing and hereafter acquired or arising trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, other business identifiers, prints and labels on which any of the foregoing have appeared or appear, all registrations and recordings thereof, and all applications (other than “intent to use” applications until a verified statement of use is filed with respect to such applications and any other Excluded Property (as defined in the Security Agreement)) in connection therewith, including, without limitation, the trademark registrations and applications listed on Exhibit A attached hereto and made a part hereof and the trademarks, and renewals thereof, and all income, royalties, damages and payments due and/or payable under or with respect to any of the foregoing, including, without limitation, damages and payments for past, present and future infringements of any of the foregoing and the right to sue for past, present and future infringements of any of the foregoing (all of the foregoing are sometimes hereinafter individually and/or collectively referred to as the “Trademarks”) , and (ii) all rights corresponding to any of the foregoing throughout the world and the goodwill of the Grantor’s business connected with the use of and symbolized by the Trademarks (together with the Trademarks, collectively, the “Trademark Collateral”);

WHEREAS, Grantor has requested that Lender (a) terminate and release the lien and interest of Lender in the Trademark Collateral, and (b) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office; and

WHEREAS, Lender has agreed to such release and termination;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby irrevocably (i) releases and terminates its security interest in and to the Trademark Collateral, and (ii) reassigns to Grantor all right, title and interest of Lender in and to the Trademark Collateral.
