

ARTICLES OF CONVERSION

Corporations Section

Pursuant to the provisions of Article 5.03 of the Texas Business Corporation Acc. Taco Bueno Restaurants, Inc. ("Converting Entity"), a Texas corporation, hereby certifies the following Articles of Conversion adopted for the purpose of effecting a conversion to Taco Bueno Restaurants, Inc., a Delaware corporation, ("Converted Entity"), in accordance with the provisions of the Texas Business Corporation Act:

ARTICLE I
