TRADEMARK ASSIGNMENT

WHEREAS, TMS Racing, Inc., a Massachusetts corporation (the "Assignor"), with a place of business at 16 S. Hunt Road, Amesbury, Massachusetts, owns all right, title, and interest in and to the trademarks and trademark registrations identified in Schedule A attached hereto (the "Marks");

WHEREAS, Turner Service, Inc., f/k/a/ Turner Motorsport, Inc., a Massachusetts corporation (the "Assignee"), with a place of business at 16 S. Hunt Road, Amesbury, Massachusetts, is desirous of acquiring said Marks, along with the goodwill of the business appurtenant to said Marks, and to which Marks pertain; and

WHEREAS, Assignor has agreed to assign to Assignee all of Assignor's right, title, and interest in and to the Marks, together with the goodwill associated therewith.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby irrevocably sells, transfers, conveys, and assigns to Assignee, its successors and assigns, Assignor's entire right, title and interest in and to the Marks, including, without limitation, all registrations and applications therefor and the right to apply for and register the Marks, in the United States of America and all foreign countries, together with the goodwill of Assignor's business in which the Marks are used and symbolized by the Marks, all common law and statutory rights related thereto, all rights of renewal and extension, and the right to sue and recover for damages and profits for past infringements thereof.

2. Upon Assignee's request and at Assignee's sole cost and expense, Assignor will promptly: (a) execute and deliver to Assignee any and all other documents of any kind whatsoever, and to provide whatever information may be required, to carry out the terms and intent of this Trademark Assignment; and (b) fully cooperate with Assignee, as reasonably required, to enable Assignee to duly record this Trademark Assignment with the United States Patent and Trademark Office so that Assignee's ownership of the Marks is duly made of record in the United States.

3. This Trademark Assignment will be governed by and construed in accordance with the laws of Delaware without reference to principles of conflicts of law.
