**THIS ASSIGNMENT OF TRADEMARKS AND TRADEMARK REGISTRATIONS** ("Assignment") is made pursuant to 15 U.S.C. § 1060, and entered into as of the effective date of January 14, 2004 (the "Effective Date"), by **Cargil International Corp.** ("Assignor"), a Florida corporation with a principal address of 6950 NW 77 Court, Miami, FL 33166, and **CE Brands, LLC**, a Florida limited liability company with a principal address of 6950 NW 77 Court, Miami, FL 33166, which was formerly known as **Augusta, L.L.C.** ("Assignee").

**WITNESSETH:**

**WHEREAS**, Assignor, by virtue of a Trademark Purchase Agreement entered into between Assignor and Assignee having an effective date of January 14, 2004, and the Amendment To Purchase Agreement executed August 4<sup>th</sup>, 2014 also having an effective date of January 14, 2004 (collectively, the "2004 Purchase Agreement"), sold to Assignee, the trademarks and trademark registrations then owned by Assignor including the goodwill of the business to which said trademarks and trademark registrations pertain (the "Marks"), and the Assignor and Assignee now desire to document the transfer of ownership of the Marks, through an assignment;

**WHEREAS**, Assignor, through the 2004 Purchase Agreement, assigned to Assignee all of its right, title and interest in and to all the Marks, including the goodwill of the business to which the Marks pertain, and Assignee acquired such rights and goodwill;



**WHEREAS**, Assignee changed its name from Augusta L.L.C. to CE Brands, LLC by virtue of the Articles of Amendment to Articles of Organization of Augusta L.L.C. filed with the Florida Secretary of State on April 28, 2009 ("CE Brands" or "Assignee");

**WHEREAS**, CE Brands is a Florida corporation with a principal address of 6950 NW 77 Court, Miami, FL 33166;



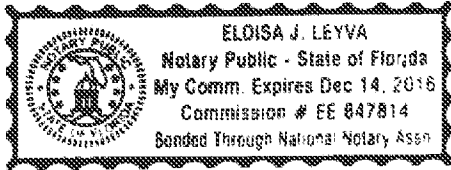

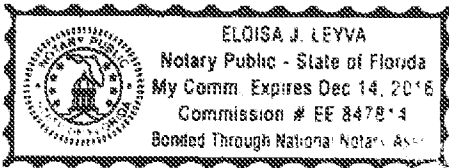
