Trademark Assignment

This Trademark Assignment (the "Assignment"), dated as of this 20th day of July, 2015, is entered into between Bakery Crafts, LLC, a Minnesota limited liability company ("Bakery Crafts") having a place of business at 3500 Thurston Avenue, Anoka, Minnesota 55303 and DecoPac, Inc., a Minnesota corporation ("DecoPac") having a place of business at 3500 Thurston Avenue, Anoka, Minnesota 55303.

WHEREAS, Bakery Crafts and DecoPac were parties to an Intellectual Property Assignment Agreement with Jack Guttman, Inc., dated June 1, 2015, pursuant to which Jack Guttman, Inc. transferred all rights, title and interest in and to the trademarks identified on the attached Exhibit A-TM (the "Marks") to Bakery Crafts; and

WHEREAS, DecoPac is desirous of acquiring all of the rights in the Marks including, the applications and registrations identified on the attached Exhibit A, and Bakery Crafts is desirous of transferring such rights to DecoPac.

NOW, THEREFORE, for good and valuable consideration received by Bakery Crafts from DecoPac, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

Bakery Crafts hereby sells, assigns, transfers, and conveys to DecoPac all rights, title, and interest in and to the Marks, including the goodwill associated with the Marks, and any applications and registrations therefor, including the applications and registrations identified on the attached Exhibit A-TM, together with that part of the business associated with the use of and symbolized by the Marks, as required by 15 U.S.C. §1060, and all causes of action and rights of recovery for past, present, or future infringement of the Marks to be held and enjoyed by DecoPac as fully and entirely as said interest could have been held and enjoyed by Bakery Crafts if this sale, assignment, and transfer had not been made. Bakery Crafts hereby authorizes the appropriate empowered officials at the United States Patent and Trademark Office to transfer all registrations and pending applications for the Marks to DecoPac as assignee of the entire right, title and interest therein or otherwise as DecoPac may direct, in accordance with this instrument of assignment.

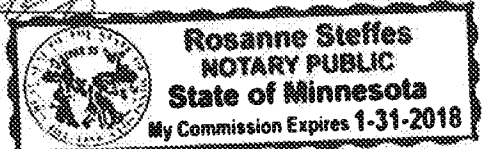
