## TRADEMARK ASSIGNMENT

WHEREAS, **CARMELYN CALVERT** (“Assignor”), an individual, resident and citizen of the United States of America having a mailing address of R.R. 1, Box 53A, Eldred, IL 62027 U.S.A., is the owner of rights in and to the trademarks, service marks and/or trade names associated with her business of developing, manufacturing, marketing, distributing, and selling the dice game known as “Square Shooters” and/or licensing others to do so (the “Business”), including without limitation those trademarks, service marks and/or trade names listed on the attached Schedule 1 hereto and the registrations and applications therefor listed on the attached Schedule 1 hereto (collectively, the “Marks”), and of the goodwill associated therewith and represented thereby in connection with the goods and services sold thereunder;

WHEREAS, Assignor desires to assign to Assignee and Assignee desires to acquire from Assignor any and all rights of the Assignor in and to the Marks, together with all of the goodwill associated therewith.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has sold, assigned, transferred, conveyed, delivered, and set over, and hereby sells, assigns, transfers, conveys, delivers, and sets over to Assignee, its successors and assigns, the entire right, title and interest in and to the Marks held by Assignor, together with all of the goodwill associated therewith, and together with all rights to bring actions against any past or present infringers of the Marks or of any rights associated therewith.

Assignor shall, at Assignee’s request, execute and deliver to Assignee such additional instruments of conveyance, assignment and transfer as may be prepared by Assignee, and take such other action as Assignee may reasonably require, in order to vest in Assignee all right, title and interest of Assignor in and to the Marks, as contemplated herein. Assignor and Assignee hereby authorize and request the U.S. Commissioner of Patents and Trademarks to record ownership of the Marks in Assignee, its successors or assigns, in accordance with the terms of this Assignment.

Assignor warrants, covenants, and agrees that she has the full and unencumbered right to sell and assign the interests herein sold and assigned, and that she has not executed and will not execute any document or instrument in conflict herewith.

Assignor hereby grants the firm Taft Stettinius & Hollister LLP, or any partner thereof, the power to insert into this Assignment any further identification which may be necessary or desirable to comply with the rules of the U.S. Patent and Trademark Office concerning recordation of this Assignment.
