**AMENDMENT NO. 1 TO
TRADEMARK SECURITY AGREEMENT**

This Amendment No. 1 (this "Amendment") to the Trademark Security Agreement, dated as of October 28, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Agreement"), is made this 22nd day of July, 2015 by and between **MINERAL FUSION NATURAL BRANDS LLC**, a Delaware limited liability company ("Debtor"), and **WEBSTER BANK, NATIONAL ASSOCIATION**, a national banking association ("Lender").

WHEREAS, on October 28, 2013, Debtor and Lender entered into that certain Loan and Security Agreement (as amended from time to time, the "LSA") securing Debtor's intellectual property as Collateral to Lender; and

WHEREAS, pursuant to Section 6 of the Agreement, Debtor and Lender desire to amend Schedule A of the Agreement; and

WHEREAS, simultaneously with the execution hereof, Debtor and Lender are amending Schedule A of the Agreement.

NOW THEREFORE, in consideration of the mutual promises, covenants and conditions set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Schedule A to the Agreement is hereby amended to incorporate the trademark disclosed on Schedule A attached hereto.
2. Subject to the LSA, all other terms and conditions of the Agreement shall remain unmodified and in full force and effect.
