## NOTICE OF TERMINATION AND RELEASE

This NOTICE OF TERMINATION AND RELEASE (this "Release") is dated as of July 23, 2015, and made by and between Rimrock Corporation, an Ohio corporation (the "Borrower"), and Commerzbank AG, New York Branch (successor-in-interest to Dresdner Bank AG, New York and Grand Cayman Branches), as Administrative Agent (the "Administrative Agent").

### WITNESSETH

WHEREAS, Dresdner Bank AG, New York and Grand Cayman Branches served as Administrative Agent under that certain Senior Credit Agreement dated as of January 28, 2003 (such agreement, together with all amendments and restatements, the "Credit Agreement"), by and among Rimrock Holdings Corporation, a Delaware corporation, Rimrock Corporation, an Ohio corporation (the "Borrower"), Rimrock Investors, L.L.C., a Delaware limited liability company, Albion Alliance Mezzanine Fund, L.P., a Delaware limited partnership, and Albion Alliance Mezzanine Fund II, L.P., a Delaware limited partnership,

WHEREAS, the Borrower had executed that certain Trademark Security Agreement dated as of January 28, 2003 (such agreement, together with all amendments and restatements, the "Trademark Security Agreement");

WHEREAS, the Borrower had executed that certain Patent Security Agreement dated as of January 28, 2003 (such agreement, together with all amendments and restatements, the "Patent Security Agreement");

WHEREAS, each of the Trademark Security Agreement and the Patent Security Agreement was subsequently recorded with the United States Patent and Trademark Office (the "USPTO");

WHEREAS, Borrower's liabilities under the Credit Agreement have been paid in full, and all commitments have been terminated; and

WHEREAS, the Administrative Agent has released all security interests and other liens granted to or held by the Administrative Agent, including the Trademark Collateral set forth on Schedule A hereto and the Patent Collateral (as set forth on Schedule B hereto).

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the parties hereby agree as follows:

1. Release of Security Interests. The Administrative Agent hereby terminates and releases all of its security interests in the Trademark Collateral and the Patent Collateral, including but not limited to, the following:
  - a. all Trademarks, including all Trademarks referred to in Schedule A attached hereto;

- b. all applications for Trademarks, including each Trademark application referred to in Schedule A attached hereto;
  - c. all Patents, including all Patents referred to in Schedule B attached hereto;
  - d. all applications for Patents, including each Patent application referred to in Schedule B attached hereto;
  - e. all proceeds and products of the foregoing, including, without limitation, insurance payable by reason of loss or damage to the foregoing.
2. Recordation with USPTO. The Borrower and the Administrative Agent desire that this Release be recorded with the USPTO so that the record may accurately reflect the release of the Administrative Agent's security interests on the Trademark Collateral and the Patent Collateral.
3. Further Assurances. The Administrative Agent agrees to execute further papers (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney or other documentation) and to do such other acts as may be necessary or requested by the Borrower to effect the release of the security interests contemplated hereby.
