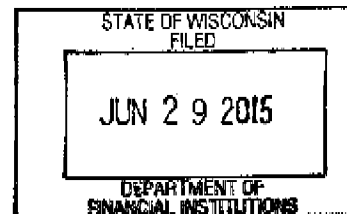

ARTICLES OF MERGER OF
WEC ACQUISITION CORP.
WITH AND INTO
INTEGRYS ENERGY GROUP, INC.



The undersigned corporation, pursuant to Sections 180.1101 and 180.1105 of the Wisconsin Business Corporation Law (the "WBCL"), for the purpose of merging WEC Acquisition Corp., a Wisconsin corporation ("Merger Sub"), into Integrys Energy Group, Inc., a Wisconsin corporation and the surviving entity in such merger (referred to herein as "Integrys" or the "Initial Surviving Corporation"), hereby executes the following Articles of Merger:

1. At the Effective Time (as defined below), Merger Sub will be merged (the "Merger") into Integrys pursuant to the terms and conditions of an Agreement and Plan of Merger (the "Plan of Merger") adopted by Integrys and Merger Sub.
2. The Plan of Merger has been approved and adopted by each corporation that is a party to the Merger in accordance with Section 180.1103 of the WBCL.
3. The Plan of Merger is on file at the principal place of business of the Initial Surviving Corporation.
4. The Initial Surviving Corporation will provide a copy of the Plan of Merger, upon request and without cost, to any shareholder of Integrys or Merger Sub or, upon payment to the Initial Surviving Corporation of an amount equal to the cost of producing the copy, to any other interested person.
5. The Articles of Incorporation of Merger Sub, a copy of which is attached hereto as Exhibit A, shall become the Articles of Incorporation of the Initial Surviving Corporation at the Effective Time of the Merger.
6. Merger Sub does not have a fee simple ownership interest in any Wisconsin real estate.
7. Merger Sub and Integrys are not direct or indirect wholly-owned subsidiaries or parents with respect to each other; therefore, the provisions of Section 180.11045 of the WBCL are not applicable to this Merger.
8. The Merger shall be effective as of 9:00 a.m. Central Time on June 29, 2015 (the "Effective Time").

IN WITNESS WHEREOF, the undersigned Corporation has caused these Articles of Merger to be executed as of the 29th day of June, 2015.

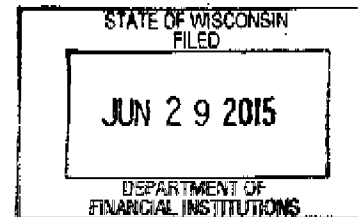

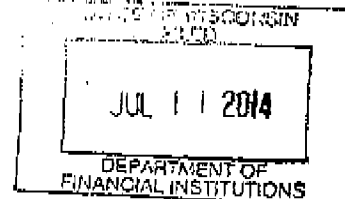

ARTICLES OF INCORPORATION
OF
WEC ACQUISITION CORP.



The undersigned, acting as incorporator of a corporation incorporated under the Wisconsin Business Corporation Law Chapter 180 of the Wisconsin Statutes (the "WBCL"), adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is WEC ACQUISITION CORP.

ARTICLE II

The corporation is organized for the purpose of engaging in any lawful activity within the purposes for which corporations may be organized under the WBCL.

ARTICLE III

The aggregate number of shares which the corporation shall have authority to issue is Ten Thousand (10,000) shares, consisting of one class only, designated as "Common Stock," of the par value of one cent (\$.01) per share.

ARTICLE IV

No holder of any stock of the corporation shall have any preemptive right to purchase, subscribe for, or otherwise acquire any shares of stock of the corporation of any class now or hereafter authorized, or any securities exchangeable for or convertible into such shares.

ARTICLE V

The Bylaws of the corporation may provide for a greater or lower quorum requirement or a greater voting requirement for shareholders or voting groups of shareholders than is provided in the WBCL.

ARTICLE VI

The address of the initial registered office of the corporation is 231 West Michigan Street, Milwaukee, Wisconsin 53203 and the name of its initial registered agent at such address is Keith H. Ecke. The county of such registered office is Milwaukee County.
