To whom it may concern:

In 2013, the Oregon Legislature passed Senate Bill 270 (OR Laws 2013, ch. 768). Pursuant to that legislation, effective July 1, 2014, the University of Oregon is a university with a governing board and no longer a part of the Oregon University System ("OUS"). The University of Oregon is an independent governmental entity of the State of Oregon.

As of July 1, 2014, by operation of law pursuant to the same legislation, intellectual property owned by the State of Oregon, the Oregon University System, the State Board of Higher Education, or a comparable State of Oregon entity, through or on behalf of the University of Oregon, is now owned by the University of Oregon, an independent governmental entity of the State of Oregon, in its own capacity.
