

MEMORANDUM OF SECURITY AGREEMENT
(Trademarks)


Pursuant to a Loan, Guaranty and Security Agreement dated as the date hereof (the "Security Agreement"), each of Vology, Inc., a Florida corporation ("Vology") and Vital Network Services, Inc., a Delaware corporation ("Vital Networks"), has granted to CAPITALSOUTH PARTNERS SBIC FUND III, L.P.
