TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is made September 11, 2013, by East 74th Street Holdings Inc., f/k/a Continental Industries, Inc., an Oklahoma corporation ("Assignor") to Hubbell Incorporated, a Connecticut corporation ("Assignee").

WHEREAS, on December 13, 2012, Assignor, Assignee, Burndy LLC, a Delaware limited liability company ("Burndy"), and Handy & Harman Group, Ltd., a Delaware corporation, entered into an Asset Purchase Agreement (the "Purchase Agreement"), pursuant to which Assignor agreed to assign to Burndy or its designee all of Assignor's title, rights and interest in and to all of Assignor's title, rights and interest in and to the trademarks set forth on Schedule A (the "Marks");

WHEREAS, in accordance with the Purchase Agreement, Burndy has designated Assignee as its designee for purposes of this Assignment; and

WHEREAS, Assignor, Burndy and Assignee wish to document the formal assignment to Assignee of all of Assignor's title, interest and rights in and to the Marks and the goodwill associated therewith.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee all of Assignor's right, title, and interest in and to the Marks, together with all translations, adaptations, derivations, and combinations thereof and including all goodwill associated therewith, and all applications, registrations, and renewals in connection therewith, and all other rights accruing thereunder or pertaining thereto throughout the world, including the right to sue and otherwise recover for all past, present, and future infringement, dilution or other violations thereof, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

Assignor authorizes the Commissioner for Patents and Trademarks and any other governmental officials to record and register this Assignment upon request by Assignee.

This Assignment shall be construed under the Laws of the State of New York, United States of America.

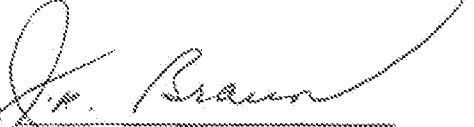

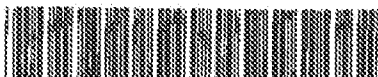

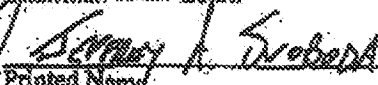

B) As amended, the name of the corporation is: East 74th Street Holdings Inc.

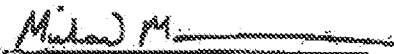

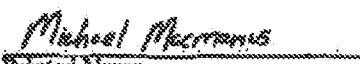
That thereafter, pursuant to said resolution of its Board of Directors, in lieu of a meeting of the shareholders of said corporation the sole shareholder approved the amendment.
