**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of July 17, 2015 (“Effective Date”) by JOHN HANCOCK LIFE INSURANCE COMPANY (U.S.A.), a Michigan corporation (successor by merger to John Hancock Life Insurance Company), HANCOCK MEZZANINE PARTNERS III L.P., A Delaware limited partnership, ALLSTATE LIFE INSURANCE COMPANY, an Illinois corporation, SIGNATURE 5 L.P., a limited partnership formed under the laws of the Cayman Islands, and SIGNATURE 7 L.P., a limited partnership formed under the laws of the Cayman Islands, (the “Secured Parties”), in favor of KNIGHTS APPAREL, INC., a Delaware corporation, with its principal office at 2221 Camden Ct., #390, Oak Brook, IL 60523 (“Grantor”).

**WHEREAS**, pursuant to the terms and conditions of that certain Amended and Restated Trademark Security Agreement by and between Grantor, on the one hand, and the Secured Parties, on the other hand, dated as of February 28, 2005 (the “Trademark Security Agreement”), Grantor granted to the Secured Parties a security interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Grantor, including, without limitation, the United States trademark applications and registrations set forth on Schedule A attached hereto, in each case, together with the goodwill associated therewith (collectively, the “Trademarks”); and

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on July 7, 2005, at Reel 3154, Frame 0162.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Parties hereby terminate the Trademark Security Agreement, and hereby terminate, cancel and release any and all security interests it has against the Trademarks.




