## DEED OF ASSIGNMENT

This Deed of Assignment is effective as of the 30<sup>th</sup> day of April, 2012.

### BETWEEN

- (1) **INTERNATIONAL FOODSTUFFS CO**, a partnership registered in UAE in the names of Mr Feroz Allana and Mr Shiraz Allana with an address at P.O. Box 4115 Al-Wadha Street, Industrial Area No. 1, Sharjah, United Arab Emirates (the "Assignor")

### AND

- (2) **INTERNATIONAL FOODSTUFFS CO. L.L.C**, a limited liability company with an address at P.O. Box 4115 Al-Wadha Street, Industrial Area No. 1, Sharjah, United Arab Emirates (the "Assignee").

### WHEREAS:-

- A. The Assignor is the record owner of trade mark number 78/614099, "ALLEGRO" registered in Class 29 (the "Trade Mark").
- B. On approximately April 30, 2012, the Assignor sold, assigned and transferred to the Assignee all its legal and beneficial rights, title and interest in the Trade Mark, together with the goodwill of the business associated with the Trade Mark, upon the terms and conditions set out in this Deed.
- C. The Assignee is the owner in fact of the Trade Mark and the parties desire to reflect this fact in the records of the U.S. Patent and Trademark Office.


NOW THIS ASSIGNMENT WITNESSETH as follows:-

1. In consideration of the sum of United States Dollars One only (US\$1.00) and other valuable consideration, the receipt and sufficiency of which the Assignor hereby acknowledges, the Assignor HEREBY ASSIGNS and transfers, *nunc pro tunc* as of April 30, 2012, all rights title and interest in the Trade Mark, including all statutory and common law rights attaching thereto and the right to sue for past infringements and to retain any damages obtained as a result of such action, to the Assignee.
2. The Assignor confirms that this assignment is made with the goodwill attaching to the Trade Mark and the goodwill of the business in which the Trade Mark has been used by the Assignor.
3. The Assignor warrants to the Assignee in respect of the Trade Mark as follows:-
  - 3.1 that the Assignor has given no permission to any third party to use them;
  - 3.2 that the Assignor is unaware of any use by any third party of the Trade Mark or any mark(s) similar to the Trade Mark in connection with the goods/services in respect of which the Assignor has used them.
  - 3.3 that no other assignment or purported assignment has been made of the Trade Mark by the Assignor.
4. This Assignment shall be governed by and construed in all respects in accordance with the laws of the Singapore and each party hereby irrevocably submits to the non-exclusive jurisdiction of the courts of Singapore.
5. This Deed may be executed in one or more counterparts, each of which when signed will be deemed to be an original and all of which when taken together will constitute one and the same Deed.


