## ASSIGNMENT OF TRADEMARKS

Assignor authorizes and requests the U.S. Patent and Trademark Office and the Internet

Corporation for Assigned Names and Numbers, or any foreign equivalent thereto, and any other relevant governmental entity, to record Assignee as owner of the Trademarks and of the entire title and interest in, to and under the same, for the sole use and enjoyment of the Assignee, its successors, assigns and other legal representatives.

This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.




