Pursuant to the provisions of Section 21-20,116 of the Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The old name of the Corporation is LapkoSoft, Inc. and the new name of the Corporation is **VM Innovations, Inc.**

SECOND: The following amendment to the Articles of Incorporation was adopted by all of the shareholders of the Corporation on February 11, 2011, in the manner prescribed by the Business Corporation Act:

BE IT RESOLVED, that the Articles of Incorporation of the Corporation be amended to read as follows:

"ARTICLE I. NAME


The name of the corporation is **VM Innovations, Inc.**"




