**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 21, 2015 ("Release"), is made by SunTrust Bank, Inc. ("SunTrust") in favor of Precision Paper Company, Universal Media Solutions, Inc., Converting Solutions, Inc. and Dietzgen Corporation (collectively, the "Grantors").

**WHEREAS**, Grantors granted to SunTrust a continuing security interest in any and all right, title and interest of the Grantors in, to, and under all the Trademarks, Trademark Licenses, and Proceeds of the foregoing;

**WHEREAS**, a notice of the grant of the security interest (the "Notice") was recorded at the United States Patent and Trademark Office ("USPTO") on May 2, 2012 at Reel 4770 Frame 0299. (Capitalized terms not defined herein shall have the meanings ascribed to them in the Notice.)

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, SunTrust agrees as follows:

**SECTION 1. Termination and Release.** SunTrust, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the Grantors' right, title, and interest in, to, and under all the Trademarks, Trademark Licenses, and Proceeds of the foregoing, including, but not limited to, the foregoing listed on Schedule A attached hereto; and

(b) authorizes the recordation of this Release with the USPTO at the Grantors' expense.


**SECTION 2. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of Florida.
