RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the "Release") is made as of July 31, 2015, by **BNP PARIBAS**, as collateral agent for the Secured Parties (as defined in the Trademark Security Agreement referred to herein) and having a business address at 787 Seventh Avenue, New York, New York 10019 (the "Collateral Agent") in favor of **RECORDED BOOKS INC. (f/k/a VOLUME HOLDINGS INC.)**, a Delaware corporation, having a business address at 270 Skipjack Road, Prince Frederick, Maryland 20678 (the "Grantor").

W I T N E S S E T H

WHEREAS, the Collateral Agent and the Grantor are parties to certain Intellectual Property Security Agreement dated as of January 31, 2014, as amended and restated in its entirety by that certain Amended and Restated Intellectual Property Security Agreement, dated as of March 19, 2014 (as so amended and restated, the "Trademark Security Agreement"), wherein Grantor granted the Collateral Agent a security interest in and continuing lien on all of the Grantor's right, title and interest in, to and under the Trademarks (as defined in the Trademark Security Agreement), including the registered U.S. trademarks and applications identified on Schedule A attached hereto;

WHEREAS, the Trademark Security Agreement was recorded with the U.S. Patent and Trademark Office on April 23, 2014 at Reel 5267, Frame 0056;

WHEREAS, the Grantor has satisfied the terms of the Trademark Security Agreement and requests a specific release of the security interest granted and recorded against the Trademarks; and

WHEREAS, the Collateral Agent, on behalf of itself and the Secured Parties, desires to grant to the Grantor a specific release of the security interest granted and recorded against each Trademark.

NOW THEREFORE, for good and valuable consideration previously tendered by the Grantor, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, on behalf of itself and the Secured Parties, does hereby terminate the Trademark Security Agreement and assign, terminate, release and discharge the entirety of the security interest in and continuing lien on the Trademarks and reassigns to the Grantor any and all right, title and interest of any nature whatsoever which it may hold in or to the Trademarks and associated common law rights and goodwill appurtenant thereto, and further agrees that it shall execute all other documents and do all other acts requested in writing by the Grantor and reasonably necessary to relinquish, confirm, effectuate or record this Release and the Grantor's right, title and interest in and to the Trademarks.
