## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the “Assignment”) is made as of July 7, 2015 and effective as of July 2, 2015, by and among **King Kold, LLC**, a Delaware limited liability (“**KK**”), Herb’s Seafood, LLC, a Delaware limited liability company authorized to do business in New Jersey using the fictitious name “New Wave Cuisine” (“**HS**”), Cuisine Innovations, LLC, a Delaware limited liability company authorized to do business in New Jersey (“**CI**”, and **KK**, **HS**, and **CI**, collectively, the “**Assignors**”), on the one hand, and **Cuisine Innovations Unlimited LLC**, a New Jersey limited liability company (“**Assignee**”), on the other hand. Capitalized terms used but not defined herein shall have the meanings for such terms that are set forth in the Purchase Agreement (as such term is defined below).

**WHEREAS**, the Assignee, the Assignors, Bon Appetizers, LLC, a Delaware limited liability company authorized to do business in New Jersey, Cohen’s Food, LLC, a Delaware limited liability company authorized to do business in New Jersey under the name “Cohens Food, LLC” and TMC Holdings, Inc. (the “Guarantor”), solely for purposes of the limited guaranty provided pursuant to Section 7.17 are parties to that certain Asset Purchase Agreement, dated as of July 7, 2015 and effective as of July 2, 2015 (the “**Purchase Agreement**”).

**WHEREAS**, Assignor desires to transfer and assign to Assignee, and Assignee desires to accept the transfer and assignment of, Assignor’s right, title and interest in, to and under the Trademarks listed on Schedule A hereto.

**NOW, THEREFORE**, Assignors, for good and valuable consideration, the receipt of which is hereby acknowledged, does hereby transfer and assign to Assignee, and Assignee hereby accepts the transfer and assignment of, Assignors’ right, title and interest in and to the Trademarks set forth on Schedule A hereto, together with the goodwill of the business associated therewith and which is symbolized thereby, all rights to sue for past, present and future infringement of any of such Trademarks.

This Assignment shall be governed by and construed in accordance with the laws of the State of New York without giving effect to the principles of conflicts of laws thereof.

This Assignment may be executed in counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.
