
Declaration

CONFIRMATORY ASSIGNMENT AGREEMENT OF WORLDWIDE TRADEMARK RIGHTS

This Confirmatory Assignment Agreement of Worldwide Trademark Rights ("Confirmatory Assignment"), effective February 1, 2004, ("Effective Date") is by and between CAROL ANDERSON, INC., a California corporation with its principal place of business at 18915 Laurel Park Road, Rancho Dominguez, California 90220 ("CA INC.") and CABI, LLC, a California limited liability company with its principal place of business at 18915 Laurel Park Road, Rancho Dominguez, California 90220 ("CABI").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, CA INC., hereby confirms that effective February 1, 2004, it sold, conveyed, assigned, transferred, and delivered to CABI, its successors, assigns and legal representatives, all worldwide right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized thereby, all rights to sue for past infringement of said Trademarks, and all causes of action (either at law or equity) with respect thereto, the right of recovery, including but not limited to damages, for such past infringement, and the right to assign the rights conveyed herein, the same to be held and enjoyed by CABI for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives.

CA INC. will from time-to-time after the Effective Date, upon request of CABI, execute, acknowledge, and deliver all such further deeds, assignments, transfers, conveyances, powers of attorney and assurances, and take such further action as may be required to carry out the intent of this Confirmatory Assignment, and to transfer and vest title to any trademark being transferred hereunder, and to protect the right, title, and interest in and enjoyment of all the Trademarks assigned hereunder.
