**IP SUPPLEMENT
(TRADEMARKS – STIX HOLDINGS, LLC)**

This IP SUPPLEMENT, dated as of July 31, 2015 is delivered pursuant to and supplements the Intellectual Property Security Agreement and License, dated as of March 29, 2012 (said Intellectual Property Security Agreement and License, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the “Intellectual Property Security Agreement”), among Stix Holdings, LLC, a Delaware limited liability company (the “Borrower”), and Wells Fargo Bank, N.A., a national banking association, in its capacity as Administrative Agent (in such capacity, the “Administrative Agent”) for the Secured Parties. Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Intellectual Property Security Agreement.

The Borrower grants to the Administrative Agent a security interest in all of the Borrower’s right, title and interest in and to the TM Collateral set forth on Schedule 1 annexed hereto. All such TM Collateral shall be deemed to be part of the TM Collateral and shall be hereafter subject to each of the terms and conditions of the Intellectual Property Security Agreement.
