THIS ASSIGNMENT is made and effective as of the 22 day April of Two thousand and Fifteen

BETWEEN

**LEGEND REGION LIMITED**, located at Sea Meadow House, Blackburne Highway, Road Town, Tortola, British Virgin Islands (hereinafter referred to as "the Assignor") of the one part;

and

**QEELIN HOLDING LUXEMBOURG**, located at 124 Boulevard de la Pétrusse, L-2330 LUXEMBOURG (hereinafter referred to as "the Assignee") of the other part.

WHEREAS the Assignor is the proprietor in all countries of the Trade Marks as listed in the Schedule annexed hereto AND WHEREAS the Assignor has agreed to assign to the Assignee the Trade Marks together with the goodwill of the business concerned in the goods for which the Trade Marks are or may become registered for the consideration hereinafter appearing.

IT IS HEREBY AGREED as follows:-

(1) In pursuance of the said agreement and in consideration of the sum of US DOLLAR ONE now paid to the Assignor by the Assignee (the receipt whereof the Assignor hereby acknowledges) the Assignor as beneficial owner does hereby assign and transfer with full title guarantee to the Assignee ALL rights, title, interests and property in the Trade Marks the full and exclusive benefit thereof, all common law rights and any copyright rights which may subsist in the Marks and all rights, privileges and advantages appertaining thereto TOGETHER WITH:-

(i) the goodwill of the business concerned in the goods/services for which the Trade Marks are or may become registered; and

(ii) the right by the Assignee to recover and to bring proceedings to recover damages and/or to obtain other remedies in respect of infringement of any rights in or relating to the Trade Marks whether committed before or after the date of this assignment, to the intent that the Trade Marks shall be in the name of and shall vest in the Assignee.

TO HOLD the same unto the Assignee absolutely.

(2) The Assignor hereby covenants and undertakes that the Assignor has not done or omitted to do and will not do or omit to do any act, matter or thing whereby the Trade Marks or any of them may be invalidated.

(3) This Agreement shall be binding upon and shall inure to the benefit of the parties hereto, their respective successors and assigns as well as any subsidiary companies of the parties hereto.

(4) This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which taken together shall constitute but one and the same instrument


