**TRADEMARK SECURITY AGREEMENT**

**TRADEMARK SECURITY AGREEMENT**, dated as of July 10, 2015 (this "Trademark Agreement") by and among **ICON HEALTH & FITNESS, INC.**, a Delaware corporation (the "Borrower"), **HF HOLDINGS, INC.**, a Delaware corporation ("Holdings"), **ICON INTERNATIONAL HOLDINGS, INC.**, a Delaware corporation ("International"), **UNIVERSAL TECHNICAL SERVICES**, a Utah corporation ("Universal"), **FREE MOTION FITNESS, INC.**, a Utah corporation ("Free Motion"), **ICON IP, INC.**, a Delaware corporation ("ICON IP"), **ICON DU CANADA INC.**, a corporation organized under the laws of the province of Quebec ("ICON du Canada"), **ICON - ALTRA LLC**, a Utah limited liability company ("ICON-Altra") and each "Additional Grantor" as described in Section 22 below (each Additional Grantor, together with Borrower, Holdings, International, Universal, Free Motion, ICON IP, ICON du Canada and ICON-Altra collectively, the "Grantors"), and **BANK OF AMERICA, N.A.**, as administrative agent and collateral agent (hereinafter, in such capacity, the "Administrative Agent") for itself and other lending institutions (hereinafter, collectively, the "Lenders") which are, or may become parties to that certain Second Amended and Restated Credit Agreement, dated as of the date hereof (as amended, amended and restated, modified or supplemented and in effect from time to time, the "Credit Agreement"), by and among the Borrower, the other Obligors party thereto, the Lenders and the Administrative Agent.

**WHEREAS**, the Grantors are Affiliates of the Borrower and the Grantors will derive direct and indirect benefits from the making of the Loans and other extensions of credit to the Borrower pursuant to the Credit Agreement (which benefits are hereby acknowledged);

**WHEREAS**, it is a condition precedent to the Lenders making any loans or otherwise extending credit to the Borrower under the Credit Agreement that the Grantors execute and deliver to the Administrative Agent, for the benefit of the Administrative Agent and the other Secured Parties, a trademark security agreement in substantially the form hereof;

**WHEREAS**, each Grantor has executed and delivered to the Administrative Agent, for the benefit of the Administrative Agent and the other Secured Parties, the Security Agreement, pursuant to which the Grantor has granted to the Administrative Agent, for the benefit of the Administrative Agent and the other Secured Parties, a security interest in certain of such Grantor's personal property and fixture assets, including without limitation the trademarks, service marks, trademark and service mark registrations, and trademark and service mark registration applications listed on Exhibit A-1 attached hereto, all to secure the payment and performance of the Secured Obligations; and

**WHEREAS**, this Trademark Agreement is supplemental to the provisions contained in (i) the Security Agreement, (ii) that certain Trademark Security Agreement dated as of the Closing Date among the Grantors and the Administrative Agent and (iii) that certain Trademark Security Agreement, dated as of September 29, 2011, among the Grantors and the Administrative Agent.

**NOW, THEREFORE**, in consideration of the premises contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:
