**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of April 10, 2015, is made by **FREEMPORT FINANCIAL PARTNERS LLC**, as administrative agent (the "**Agent**"), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement), in favor of Beers Enterprises, Incorporated (the "**Borrower**").

**WHEREAS**, in connection with that certain Credit Agreement dated as of March 19, 2014 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "**Credit Agreement**"), among the Borrower, the other Loan Parties, the Lenders from time to time party thereto and the Agent, and together with all general security agreements, trademark security agreements and patent security agreements entered into in connection therewith or in connection with prior versions thereof, the Lenders made loans and other financial accommodations to the Borrower;

**WHEREAS**, in connection with the Credit Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Security Agreements**"), the Borrower granted security interests in the intellectual property owned by Borrower, including those listed on Annex I attached hereto (the "**Intellectual Property Collateral**"); and

**WHEREAS**, the Security Agreements were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Annex I hereto.

**NOW THEREFORE**, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby **RELEASES**, terminates and discharges, without representation, or warranty whatsoever, all of its rights in, to and under, including its Lien on and security interest in, and right of setoff against, the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Agent hereby reassigns any and all right, title and interest (if any) that the Agent may have in, to and under the Intellectual Property Collateral to Borrower.


The Agent shall, at Borrower's expense, cooperate with Borrower and provide Borrower with the information and additional authorization and documents as may be requested by Borrower to evidence, record and effect the release of the Agent's security interest in, and (as applicable) reassignment of, the released collateral described herein.
