

NTS Acquisition Corp., a corporation organized and existing under the Delaware General Corporation Law ("DGCL"), hereby certifies as follows:

FIRST: The name of this corporation is NTS Acquisition Corp. (the "Corporation").


SECOND: The Certificate of Incorporation of the Corporation was filed by the Secretary of State of the State of Delaware on March 5, 2012.
