RELEASE OF FIRST LIEN TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Release”) is made as of August 4, 2015 (the “Effective Date”), by Bank of America, N.A., as first lien administrative agent (in such capacity, the “Administrative Agent”), in favor of Ardent Medical Services, Inc. and AHS Oklahoma Heart, LLC (the “Pledgors”).

WHEREAS, pursuant to the terms and conditions of that certain Notice of Grant of Security Interest in Trademarks among the Pledgors and the Administrative Agent dated as of January 2, 2013 (the “Trademark Security Agreement”), the Pledgors pledged and granted to the Administrative Agent a lien on and security interest in all of its right, title and interest in and to certain collateral identified in said Trademark Security Agreement including, without limitation, the trademarks set forth on Schedule I hereto, along with the goodwill associated therewith (collectively, the “Trademarks”);

WHEREAS, the Trademark Security Agreement was recorded with the Assignment Division of the U.S. Patent & Trademark Office on April 17, 2014, at Reel 5262 and Frame 0614;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, discharges, reassigns and releases any and all liens and security interests it has in and against the Trademarks arising under the Trademark Security Agreement.



The Administrative Agent shall take all further actions, and provide to the Pledgors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgors, and at Pledgors’ cost and expense, to more fully and effectively effectuate the purposes of this Release.
