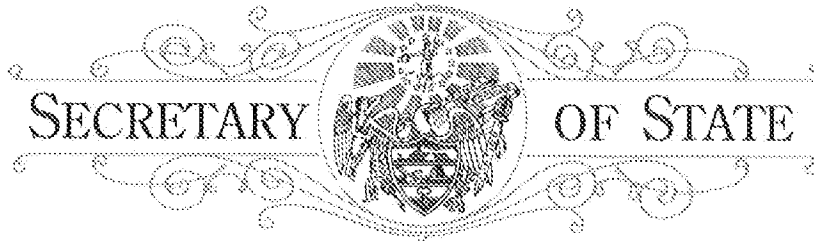

3. The Articles of Organization shall be amended by deleting Article First in its entirety


and replacing it as follows:
