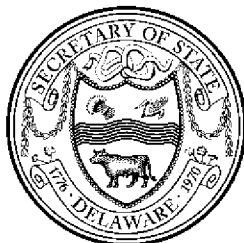

THIRD: The name of the surviving entity in the Merger (the "**Surviving Company**") shall be **iHT Services, LLC**, a Delaware limited liability company.


FOURTH: No amendments to the certificate of formation of the **Surviving Company** are being effected by the Merger.
