

ASSIGNORS authorize the Commissioner of Patents and Trademarks of the United States, and any other official throughout the world whose duty is to register and record ownership in trademark registrations and applications for registration of trademarks, to record the ASSIGNEE as the ASSIGNEE and owner of any and all of such ASSIGNOR'S rights in the Trademarks.
