U.S. TRADEMARKS RELEASE OF SECURITY INTEREST

THIS RELEASE dated as of June 10, 2015, by Bank of America, N.A., as Agent (as defined below) for the Lenders. Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement referred to below.

A. Reference is made to the Credit Agreement dated as of December 5, 2011 (as amended, restated or otherwise modified from time to time, the "*Credit Agreement*"), by and among MLIM, LLC, a Delaware limited liability company ("*MLIM*"), The San Diego Union-Tribune, LLC, a Delaware limited liability company ("*SDUT*"), DiscoverSD, LLC, a Delaware limited liability company ("*DiscoverSD*" and, together with MLIM and SDUT, the "*Borrowers*"), the Guarantors party thereto, the Lenders party thereto and Bank of America, N.A., as Administrative Agent for the Lenders ("*Agent*") and L/C Issuer.

B. Reference is made to the Trademark Security Agreement, dated as of December 5, 2011, (the "*Security Agreement*"), among the Grantors (as defined in the Security Agreement) in favor of the Agent, pursuant to which, among other things, the Grantors granted a security interest to the Agent, for the benefit of certain secured parties named therein, in, among other things, the registered trademarks and pending trademark applications of the Borrowers as set forth on Schedule A hereto (the "*Trademarks*"), which security interest was recorded with the United States Patent & Trademark Office on December 16, 2011 on Reel 004681 Frame 0006.

C. In connection with the termination of the Credit Agreement, the Borrowers have informed the Agent of their desire to obtain the release of all right, title and interest of the Agent, the Lenders and each other grantee or beneficiary in and to the Trademarks granted under the Security Agreement.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all the Agent's right, title and interest (including, without limitation, security interests) in and to the Trademarks pursuant to the Security Agreement shall automatically terminate as provided in the Security Agreement, including, without limitation, the Trademarks set forth on Schedule A attached hereto, the debt secured thereby having been paid and satisfied in full.
