## RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (this “**Release**”), dated as of August 3, 2015, is made by Deutsche Bank AG New York Branch, for itself and in its capacity as Collateral Agent (the “**Assignor**”), in favor of AMS Research, LLC (formerly AMS Research Corporation), a Delaware limited liability company and Laserscope, a California corporation (together, the “**Assignees**”).

W I T N E S S E T H:

**WHEREAS**, Endo Limited, a company incorporated under the laws of the Republic of Ireland (Registered Number 534651) having its registered office at First Floor, Minerva House, Simonscourt Road, Ballsbridge, Dublin 4, Ireland (the “**Irish Holdco**”), Endo Management Limited, a company incorporated under the laws of the Republic of Ireland (Registered Number 538432) having its registered office at First Floor, Minerva House, Simonscourt Road, Ballsbridge, Dublin 4, Ireland (the “**Irish Sub Holdco**”), Endo Luxembourg Holding Company S.à r.l., a *société à responsabilité limitée* (private limited liability company) incorporated under the laws of the Grand Duchy of Luxembourg (“**Luxembourg**”), having its registered office at 2a, rue Nicolas Bové, L-1253 Luxembourg, with a share capital of USD 123,695,800 and registered with the Luxembourg Register of Commerce and Companies (the “**Luxembourg Companies Register**”) under number B182.517 (“**Lux Holdco**”), Endo Luxembourg Finance Company I S.à r.l., a *société à responsabilité limitée* (private limited liability company) incorporated under the laws of Luxembourg, having its registered office at 2a, rue Nicolas Bové, L-1253 Luxembourg, with a share capital of USD 123,695,800 and registered with the Luxembourg Companies Register under number B182.645 (the “**Lux Borrower**”), Endo LLC, a Delaware limited liability company (the “**Co-Borrower**”), the Lenders and the Grantee have entered into a Credit Agreement dated as of February 28, 2014 (as amended as of June 12, 2015, and as may be further amended, restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”);

**WHEREAS**, the Assignees and the Assignor are parties to (i) that certain US Pledge and Security Agreement, dated as of February 28, 2014 (as may be amended, restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) and (ii) that certain Confirmatory Grant of Security Interest in United States Trademarks, dated as of February 28, 2014 (the “**Trademark Security Agreement**”);

**WHEREAS**, pursuant to the Trademark Security Agreement, the Assignees pledged and granted to the Assignor, on behalf of and for the benefit of the Secured Parties, a security interest in (other than applications for trademarks or service marks filed in the United States Patent and Trademark Office or any successor office thereto pursuant to 15 U.S.C. §1051 Section 1(b) unless and until evidence of use of the mark in interstate commerce is submitted to the United States Patent and Trademark Office or any successor office thereto pursuant to 15 U.S.C. §1051 Section 1(c) or Section 1(d)) all of the Assignees’ right, title and interest, wherever

located and whether now owned or hereafter acquired, in and to (collectively, the “**Trademark Collateral**”):

- (a) its trademarks (including service marks), trade names, trade styles, trade dress and the registrations and applications for registration thereof, including the Trademarks and the goodwill of the business symbolized by the foregoing;
- (b) all renewals of the foregoing;
- (c) all income, royalties, damages, claims and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims, and payments for past and future infringements thereof;
- (d) all rights to sue for past, present, and future infringements of the foregoing, including the right to settle suits involving claims and demands for royalties owing; and
- (e) all rights corresponding to any of the foregoing throughout the world.

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 20, 2014 at Reel/Frame No. 5242/0195.

**WHEREAS**, in accordance with the terms of the Partial Release of Collateral and Guarantor Release (the “**Payoff Letter**”), dated on or about the date of this Release and given by the Assignor, the obligations secured by the Trademark Collateral have been repaid or otherwise satisfied to the extent set forth in the Payoff Letter.

**WHEREAS**, the Assignees desire that the Assignor terminate and release, and the Assignor desires to terminate and release the Assignor’s lien on and security interest in and to all right, title and interest in, to and under all of the Trademark Collateral.

**NOW THEREFORE**, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor agrees as follows:

**SECTION 1. Defined Terms.** Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Trademark Security Agreement.

**SECTION 2. Termination and Release.** The Assignor hereby terminates, releases and discharges fully, without representation, warranty or recourse of any kind, its lien on and security interest in and to all right, title and interest in, to and under the Trademark Collateral, including the Trademarks listed on Schedule I attached hereto, and reassigns and transfers to the Assignees all right, title and interest that the Assignor may have in the Trademark Collateral.

**SECTION 3. Recordation.** The Assignor hereby authorizes the Assignees, or the Assignees’ authorized representative, to record this Release with the United States Patent and Trademark Office.






