### TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (hereinafter referred to as "Assignment") is made by and between JOSEPH J. BISOGNO, an individual residing at 11017 Glenview Lane, Olathe, Kansas 66061 (the "Assignor"), and OREGANO'S PIZZA BISTRO, INC., a Delaware corporation with a business address at 7217 East Shea Boulevard, Scottsdale, Arizona (the "Assignee") (collectively, the Assignor and the Assignee are referred to herein as the "Parties").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee all Assignor's right, title, and interest in and to the Mark and the Registration, including common law rights, together with the goodwill of the business symbolized by the Mark and the Registration, and all rights to damages and profits, due or accrued, arising out of past infringements of said Mark and Registration, and the right to sue for and recover the same. Assignor hereby assigns to Assignee the entire business associated with the Mark and the Registration being transferred. Assignor agrees to take further action as deemed necessary or appropriate by Assignee to properly and fully effect and perfect the transfer to Assignee of the Mark and the Registration, including executing such other documents and/or instruments of assignment, transfer and conveyance as Assignee may reasonably request to permit Assignee to record the assignment made by this instrument or any other documents Assignee may reasonably deem necessary or advisable to effectuate the terms and intent of this Trademark Assignment.
