**TERMINATION OF TRADEMARK SECURITY AGREEMENT AND  
RELEASE OF LIENS AND SECURITY INTEREST IN TRADEMARKS**

This TERMINATION OF TRADEMARK SECURITY AGREEMENT AND **RELEASE OF LIENS AND SECURITY INTEREST IN TRADEMARKS** (this “*Release*”) is made as of August 3, 2015 by SUNTRUST BANK (the “*Lender*”).

WITNESSETH:

WHEREAS, pursuant to that certain (i) Security and Pledge Agreement dated as of April 15, 2014 and (ii) the Grant of a Security Interest- Trademarks dated as of November 18, 2014, as each may have been amended, restated, supplemented or otherwise modified from time to time (the “*Security Agreement*”), Kidrobot, Inc. granted to the Lender a security interest in the trademarks set forth on Exhibit A (collectively, the “*Trademarks*”);

WHEREAS, the Security Interest was recorded at Reel 005403, Frame(s) 0765, on November 18, 2014, with the United States Patent and Trademark Office;

WHEREAS, Kidrobot, Inc. subsequently merged into KR Purchase LLC, and KR Purchase LLC then changed its name to Kidrobot LLC (the “*Company*”); and


WHEREAS, the Company has requested that the Lender release its lien on the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby (i) releases any and all rights, claims, security interests, liens, and other encumbrances in and to the Trademarks and reassigns any and all rights, titles and interests therein, without any representation, warranty, recourse of any kind (either express or implied) or undertaking by the Lender, to the Company, and (ii) terminates the Security Agreement and releases all of Lender’s rights thereunder.
