## **TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of February 24, 2015, by GE BUSINESS FINANCIAL SERVICES INC. (formerly known as Merrill Lynch Capital, a division of Merrill Lynch Business Financial Services Inc.), as Administrative Agent for the Lenders (“**Agent**”). All terms capitalized but not otherwise defined herein shall have the respective meanings provided in the Agreement (as defined below).

### WITNESSETH:

WHEREAS, Agent and M&M Manufacturing, L.P., a Texas limited partnership (now M&M Manufacturing, LLC, a Delaware limited liability company) (“**Grantor**”), were parties to that certain Trademark Security Agreement, dated as June 11, 2007 (the “**Agreement**”), pursuant to which Grantor granted a security interest to Agent in the Trademark Collateral as security for certain obligations owing by Grantor to Agent and the Lenders, including the Trademarks set forth on Exhibit A hereto; and

WHEREAS, the Agreement was recorded by the United States Patent and Trademark Office on June 20, 2007, at Reel 003564, Frame 0363; and

WHEREAS, Grantors have requested that Agent release its security interest in the Trademark Collateral.


