## INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE

THIS U.S. INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE (this "*Release*") is made effective as of July 31, 2015, by Bank of America, N.A. ("*Bank of America*") as agent (the "*Agent*") in favor of TV One Broadcast Sales Corporation (as successor-in-interest to certain of the Collateral, as defined below, listed in the Schedules attached hereto) and Magenta Research Limited ("*Magenta*" and, with TV One Broadcast Sales Corporation, the "*Grantors*").

WHEREAS, Magenta entered into that certain U.S. Intellectual Property Security Agreement, dated as of December 17, 2009 (as amended, restated, supplemented or otherwise modified from time to time, the "*IP Security Agreement*") whereby Magenta granted to the Agent a security interest in and to certain intellectual property of Magenta;

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on January 8, 2010 at Reel 23750 and Frame 40, with respect to U.S. patents and patent applications and on January 8, 2010 at Reel 4126 and Frame 0864, with respect to U.S. trademarks and trademark applications; and

WHEREAS, in accordance with the provisions of the IP Security Agreement, the Agent now desires to release its security interest in and to the Collateral (as defined below).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

SECTION 1. Release of Grant of Security. The Agent hereby releases to the Grantors its security interest in all of the Grantors' right, title and interest in and to the following (the "*Collateral*");

- (i) all patents and patent applications, including the patents and patent applications set forth in Schedule A hereto;
- (ii) all trademark and service mark registrations and applications, including the trademark registrations and applications set forth in Schedule B hereto, together with the goodwill symbolized thereby;
- (iii) all copyrights, whether registered or unregistered;
- (iv) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantors accruing thereunder and pertaining thereto;
- (v) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect

to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and

- (vi) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral of or arising from any of the foregoing.


