DEED OF ASSIGNMENT

THIS DEED is made the 27 day of February 2015

B E T W E E N:

Orica Australia Pty Ltd, of 1 Nicholson Street, East Melbourne, Victoria 3000, AUSTRALIA (hereinafter called "the Assignor") of the one part

AND

Chemicals Australia Operations Pty Ltd, of 1 Nicholson Street, East Melbourne, Victoria 3002, AUSTRALIA (hereinafter called "the Assignee") of the other part.

WHEREAS:

- A. The Assignor is the proprietor of the trade mark applications and registrations as set out in the attached Schedule ("the trade marks").
- B. The Assignee wishes to acquire the trade marks with the goodwill of the business concerned in the goods and services in respect of which the trade marks are registered.
- C. The Assignor has agreed to transfer the trade marks to the Assignee.

NOW THIS DEED WITNESSES:

- 1. For good and valuable consideration, the sufficiency and receipt of which the Assignor hereby acknowledges, the Assignor hereby assigns, transfers and sets over with effect on and from 27 February 2015 all the right, title and interest of the Assignor in and to the trade marks with the goodwill of the business concerned in the goods and services in respect of which the trade marks are registered to the Assignee absolutely together with all claims, demands, causes of action and rights of action for infringement or otherwise accrued or accruing and all rights to costs, damages, profits, penalties and all other relief in respect thereof.



The Assignor agrees to execute all documents to enable the Assignee to apply for and obtain registration as the registered owner of the trade marks and, at the expense of the Assignee, to execute all documents and render all assistance reasonably required by the Assignee for the purposes of confirming the Assignee's title to the trade marks.

3. **General**

- a) No variation of this Deed will be of any force or effect unless it is in writing and signed by the parties to this documents.
- b) This Deed is governed by the laws of Australia. The parties submit to the non-exclusive jurisdiction of its courts of appeal from them. The parties will not object to the exercise of jurisdiction by those courts on any basis.
- c) This Deed may be executed in any number of counterparts. All counterparts together will be taken to constitute one instrument.
