ARTICLES OF INCORPORATION OF

of and acting for **DEVIN RENTAL TOOLS, INC.**, a corporation organized and existing under the laws of the State of Louisiana ("Corporation") and who, after being duly sworn, did declare and acknowledge and certify that:

- (1) Mark S. Yuille is the duly elected President of the Corporation and Lyle E. Girouard is the duly elected Treasurer of the Corporation;
- (2) The Stockholders and Directors of the Corporation have unanimously approved and adopted an Amendment to the Articles of Incorporation of the Corporation, for the purpose of making a corporate name change, in writing, by Unanimous Consent on August 31, 2008, an original of which is annexed hereto and made a part hereof; and
- (3) The said Mark S. Yuille and Lyle E. Girouard now appear for the purpose of effecting an Amendment to the Articles of Incorporation, so as to restate Article I to read as follows:

"ARTICLE I

The name of this corporation is: **DEVIN INTERNATIONAL, INC.**"

NOW THEREFORE, in consideration of the foregoing and in accordance with La. R.S. 12:31 et seq. of the Louisiana Business Corporation Law, the Articles of Incorporation of Devin Rental Tools, Inc. are hereby amended as follows:

Article I of the Articles of Incorporation is hereby amended and restated in its entirety as follows:

"ARTICLE I

The name of this corporation is: **DEVIN INTERNATIONAL, INC.**"

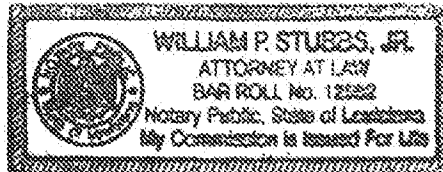

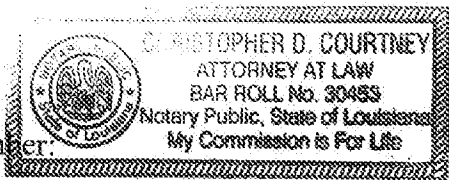
