EMMIS INTERACTIVE, INC.  
(an Indiana corporation)

In compliance with the requirements of the Indiana Business Corporation Law, as amended ("IBCL"), the undersigned corporation, desiring to effect a merger, sets forth the following facts:

Article I

SURVIVING CORPORATION

Section 1. The name of the corporation that will survive the merger is Emmis Interactive, Inc. (the "Surviving Corporation") and such name will be changed to "Marketron Interactive, Inc." as a result of the merger.

Section 2. The Surviving Corporation is an Indiana corporation incorporated under the IBCL on November 13, 2007.

Article II

NONSURVIVING CORPORATION

The name, state of incorporation, and date of incorporation of each corporation, other than the survivor, which is a party to the merger (the "Nonsurviving Corporation") are as follows:

The Articles of Incorporation of the Surviving Corporation, as so amended and restated, are set forth on Exhibit A, and shall continue as such until altered, amended, repealed or restated.

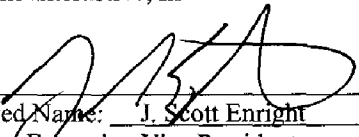

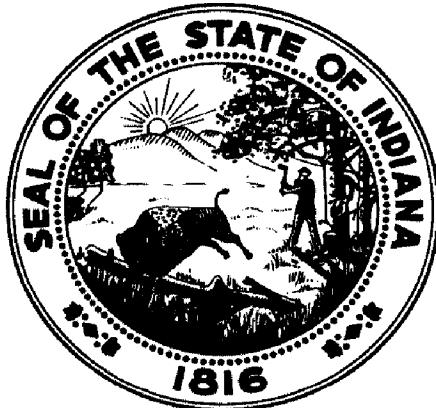
