RELEASE AND TERMINATION
OF
TRADEMARK SECURITY AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, that a certain Trademark Security Agreement, dated as of June 4, 2010 (as reaffirmed by that certain Reaffirmation of Trademark Security Agreement, dated as of August 29, 2014, the "Trademark Security Agreement") was executed by The Schumacher Group of Delaware, Inc., a Delaware corporation (the "Debtor"), pursuant to which the Debtor granted to General Electric Capital Corporation, on behalf of itself and Lenders (the "Agent"), a continuing first priority security interest in all of Debtor's right, title and interest in, to and under the Trademark Collateral more fully described on Schedule 1 annexed hereto and made a part hereof. Capitalized terms used herein and not otherwise defined have the meanings ascribed to them in the Trademark Security Agreement.

WHEREAS, the Trademark Security Agreement was previously recorded in the United States Patent and Trademark Office ("USPTO") on June 4, 2010 at Reel No. 5109, Frame No. 0144.

WHEREAS, the Agent has agreed to release its interest in the Trademark Collateral, reconvey any and all rights in the Trademark Collateral to the Debtor, and discharge the Trademark Security Agreement.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent hereby releases all of its right, title and interest in the Trademark Collateral which was pledged, mortgaged and set over or otherwise made subject to a lien to the Agent by Debtor pursuant to the Trademark Security Agreement, re-assigns to the Debtor any and all right, title or interest it may have in such Trademark Collateral, and terminates the Trademark Security Agreement.

This agreement shall be governed by and construed and enforced in accordance with the internal laws (as opposed to conflicts of law provisions) of the State of New York.
