RELEASE OF TRADEMARK SECURITY INTERESTS

WHEREAS, pursuant to the terms and conditions of (i) that certain Trademark Security Agreement, dated as of January 3, 2011 and recorded with the United States Patent and Trademark Office on January 3, 2011 at Reel 004445, Frame 0737, as amended by that certain First Amendment to Trademark Security Agreement, dated as of August 10, 2012 and recorded with the United States Patent and Trademark Office on August 13, 2012 at Reel 4841 Frame 0080, (ii) that certain Trademark Security Agreement, dated as of January 3, 2011 and recorded with the United States Patent and Trademark Office on January 3, 2011 at Reel 004445, Frame 0745, as amended by that certain First Amendment to Trademark Security Agreement, dated as of August 10, 2012 and recorded with the United States Patent and Trademark Office on August 13, 2012 at Reel 4841 Frame 0096, (iii) that certain Trademark Security Agreement, dated as of June 6, 2012 and recorded with the United States Patent and Trademark Office on June 7, 2012 at Reel 004796, Frame 0642, (iv) that certain Trademark Security Agreement, dated as of August 10, 2012 and recorded with the United States Patent and Trademark Office on August 10, 2012 at Reel 004840, Frame 0407 and (v) that certain Trademark Security Agreement, dated as of January 31, 2014 and recorded with the United States Patent and Trademark Office on February 5, 2014 at Reel 005208, Frame 0811 (each as amended, restated, supplemented or otherwise modified on or prior to the date hereof, collectively, the "**Trademark Security Agreements**"), in each case made by the Grantors party thereto in favor of the Grantee and (vi) the Amended and Restated Guaranty and Security Agreement, dated as of July 21, 2013, by the Grantors party thereto in favor of Grantee (which amended and restated in its entirety that certain Guaranty and Security Agreement dated of January 3, 2011, made by the Grantors party thereto in favor of Grantee) (as amended, restated, supplemented or otherwise modified on or prior to the date hereof, the "**Security Agreement**"), Grantors pledged and assigned to Grantee, a continuing security interest in the trademarks and IP licenses listed on Schedule 1 attached hereto (collectively, the "**Trademarks**"), together with, among other things, the goodwill of the business symbolized by and associated with the Trademarks and the applications and registrations thereof, and all proceeds thereof (collectively, including the Trademarks, the "**Trademark Collateral**").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby (i) terminates the Trademark Security Agreements, and (ii) releases, without any representation, recourse or undertaking by Grantee, any and all liens on and security interests in the Grantors' Trademark Collateral granted pursuant to the Trademark Security Agreements and/or the Security Agreement, including the Trademark Collateral listed on Schedule 1 hereto.
