**RELEASE OF SECURITY INTEREST

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of August 12, 2015, is made by ARES CAPITAL CORPORATION, as Administrative Agent ("Agent") under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, in connection with that certain Credit Agreement dated as of June 13, 2012 (as amended, restated, supplemented or otherwise modified to date, the "Credit Agreement"), among Cast & Crew Payroll, LLC (the "Borrower"), Payroll Holdings, LLC and the Lenders signatory thereto from time to time, the Lenders made credit extensions to the Borrower;

WHEREAS, in connection with the Credit Agreement and that certain Guaranty and Security Agreement dated as of June 13, 2012 (as amended, restated, supplemented or otherwise modified to date, the "Security Agreement"), among the Borrower, the other Grantors (as defined therein) and Agent, and pursuant to those agreements described on Annex I attached hereto (collectively, the "Short-Form Security Agreements"), the Borrower granted security interests in certain intellectual property owned by it including those listed on Annex I attached hereto (collectively, the "Intellectual Property Collateral"); and

WHEREAS, the Short-Form Security Agreements were recorded in the United States Patent and Trademark Office (the "USPTO") in the reel and frame numbers as set forth on Annex I hereto.


