## TRADEMARK ASSIGNMENT

Each Assignor does hereby irrevocably assign, transfer, convey and deliver to Assignee and Assignee hereby accepts, all of such Assignor’s right, title and interest in and to the Marks, including any common law or statutory rights associated therewith, together with the goodwill of the business associated with the use of and symbolized by the Marks (if any), and all the trademark applications and registrations therefor, and all rights to (i) bring an action solely related to the Marks, whether at law or in equity, for past, present or future infringement, dilution, misappropriation, misuse or other violation of the Marks against any third party, (ii) any proceeds, benefits, privileges, causes of action, and remedies solely relating to the Marks, and (iii) recover damages, profits and injunctive relief for all past, present or future infringement, dilution, misappropriation, misuse or other violation of the Marks.

This Trademark Assignment shall be governed by and construed in accordance with the laws of the State of New York, without regard for conflicts of law, principles or rules of such state, to the extent such principles or rules would permit or require the application of the laws of another jurisdiction.

This Trademark Assignment may be executed in two or more counterparts, each of which shall be deemed to be an original and all of which shall constitute the same Agreement.
