RELEASE OF TRADEMARK SECURITY AGREEMENT

(Senior Subordinated Debt)

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT ("Release"), dated as of August 6, 2015, is made by FIFTH THIRD BANK, an Ohio banking corporation, as Secured Party, solely through its Mezzanine Finance Group ("Secured Party"), and is as follows:

WHEREAS, Secured Party and DHM ACQUISITION CORP., a Delaware corporation ("Debtor"), are parties to that certain Second Amended and Restated Trademark Security Agreement (Senior Subordinated Debt), dated as of February 21, 2014 (the "Agreement"), which was recorded with The United States Patent and Trademark Office on March 28, 2014 in its records at Reel 5246, Frame 0079. Capitalized terms used, but not defined, herein shall have the meanings given to them in the Agreement;

WHEREAS, the Agreement granted to Secured Party a continuing security interest in and to, and Lien on, all of the Trademark Collateral, including each mark, registration, and application listed on Schedule I attached hereto and made a part hereof;

WHEREAS, Fifth Third Bank, an Ohio banking corporation, as Secured Party (as defined in the Senior Agreement) through its Structured Finance Group ("Senior Secured Party"), and Debtor are parties to that certain Third Amended and Restated Trademark Security Agreement, dated as of February 21, 2014 (the "Senior Agreement"), which was recorded with The United States Patent and Trademark Office on March 28, 2014 at Reel 5246, Frame 0093;

WHEREAS, the Agreement granted to Secured Party a continuing security interest in and to, and Lien on, (a) all of Debtor's right, title and interest in and to all of its now or in the future owned or existing trademarks, service marks, trademark or service mark registrations, trade names, and trademark or service mark applications (except as provided in the Agreement), including each mark, registration, and application listed on Schedule I attached hereto and made a part hereof (the property in this item (a) being, collectively, the "Trademarks"); (b) all renewals of each of the Trademarks; (c) all income, royalties, damages and payments now and in the future due or payable under or with respect to any and all of the Trademarks, including damages and payments for past or future infringements of any and all of the Trademarks; (d) all rights to sue for past, present and future infringements of any and all of the Trademarks; (e) all rights corresponding to any and all of the Trademarks throughout the world; (f) all rights of Debtor as licensor or licensee under, and with respect to, trademarks, service marks, trade names, and trademark and service mark registrations and applications; and (g) together in each case with the goodwill of Debtor's business connected with the use of, and symbolized by, the foregoing; and


WHEREAS, Secured Party desires to release its rights and security interests in the Trademark Collateral solely as granted under the Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby fully and finally releases and terminates its security interest in, Liens on, and all other rights in, to and under the Trademark Collateral solely

as granted under the Agreement (including, but not limited to, as recorded at Reel/Frame 5246/0079); *provided*, however, that nothing in this Release shall be construed as terminating, releasing, decreasing, diminishing, or in any other way altering any Lien or security interest for the benefit of the Senior Secured Party under the Senior Agreement (including, but not limited to, as recorded as Reel/Frame 5246/0093), which remains in full force and effect.
