RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), is entered into as of April 17, 2015 by Advantage Capital Community Development Fund XXVIII, LLC, a Delaware limited liability company, as administrative agent for the Secured Parties (in such capacity, the "Agent") in connection with the grant of security interests in certain trademarks by Atlas Paper Mills, LLC, a Delaware limited liability company (the "Grantor"), in favor of the Agent.

WITNESSETH:

WHEREAS, the Grantor entered into an agreement with the Agent which was recorded in the Trademark Division of the United States Patent and Trademark Office ("USPTO") on July 18, 2012, at Reel 4824, Frame 0333 (the "Trademark Security Agreement") for the purpose of providing certain trademarks as collateral security for the payment and performance of certain obligations of the Grantor to the Agent; and

WHEREAS, the Agent now desires to terminate and release the entirety of its security interests in the Collateral (as defined below);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Definitions. The term "Collateral", as used herein, shall have the meaning set forth in the Trademark Security Agreement, including, without limitation, those trademarks and trademark registrations listed on Schedule A hereto.

2. Release of Security Interest. The Agent hereby (i) terminates, cancels, releases and discharges all of its security interests it has against the Collateral without representation, warranty or recourse of any kind or nature, and (ii) reassigns any right, title and interest it may have in, to and under the Collateral to the Grantor.

3. Further Assurances. The Agent shall, at the Grantor's sole cost and expense, and without representation, warranty or recourse, take all further actions, and provide to the Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Release.

4. Recordation of Release. The Agent hereby authorizes the Grantor or the Grantor's authorized representative to record this Release with the USPTO.

5. Governing Law. This Release, and the rights and obligations of the parties hereunder, shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York, without reference to conflicts of law provisions.
