

This Assignment shall be binding upon the parties, their successors and/or assigns, and all others acting by, through, with or under their direction, and all those in privity therewith.

Assignor further authorizes the Commissioner of Patents and Trademarks of the United States and/or any other office whose duty it is to record trademark registrations, assignments, applications and title thereto, to record the transfer/assignment of the Trademarks and Trademark Applications and all rights, title, and interest thereto to Assignee as the property of Assignee, its successors, legal representatives and assigns, if applicable, in accordance with the terms of this Assignment.


