RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is made as of August 14, 2015 (“**Effective Date**”) by GCI Capital Markets LLC (“**GCI**”), a Delaware limited liability company, in its capacity as administrative agent (“**Administrative Agent**”) for the Secured Parties in favor of Capital Vision Services, LLC, a Delaware limited liability company (“**Grantor**”).

WHEREAS, pursuant to that certain Credit Agreement dated as of December 3, 2012, by and among Grantor, the other Loan Party thereto, Administrative Agent, and the Lenders party thereto from time to time (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the “**Credit Agreement**”), the Lenders agreed to make Loans to Grantor;

WHEREAS, pursuant to that certain Security Agreement dated as of December 3, 2012, by and among Grantor, the other grantors party thereto, and Administrative Agent (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the “**Security Agreement**”), as security for all Obligations under the Credit Agreement and other Loan Documents, Grantor granted to Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in, lien on, and right of set-off against all Trademarks of Grantor, whether now owned or hereafter acquired or arising;

WHEREAS, in connection with the Security Agreement, and in order to secure Grantor’s Obligations, Grantor and Administrative Agent entered into that certain Trademark Security Agreement dated as of December 3, 2012, and amended (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the “**Trademark Security Agreement**”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 3, 2012 at Reel/Frame 4911/0506;

WHEREAS, Grantor and Administrative Agent entered into that certain First Amendment to Trademark Security Agreement dated as of December 1, 2014, by and among Grantor and Administrative Agent, (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the “**Amended Trademark Security Agreement**”) in order to amend and restate Schedule A to the Trademark Security Agreement;

WHEREAS, the Amended Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 7, 2014 at Reel/Frame 5415/0072;

WHEREAS, pursuant to the Trademark Security Agreement and the Amended Trademark Security Agreement, Grantor granted to Administrative Agent, for the ratable benefit of the Secured Parties, a first priority security interest in, and lien upon, all of Grantor’s then existing or thereafter acquired right, title and interest in and to the Trademarks, including, without limitation, the Trademarks set forth on Schedule A attached hereto, all related goodwill, and all proceeds and products thereof (the “**Trademark Collateral**”); and

WHEREAS, Administrative Agent wishes to release its security interest in, and lien upon, the Trademark Collateral.

NOW, THEREFORE, in consideration of the premises herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby releases its security interest in, and lien upon, the Trademark Collateral.




