TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Trademark Assignment") is made and entered into as of April 30, 2015, by International Paper Company, a New York corporation, having a place of business at 6400 Poplar Avenue, Memphis, TN 38197 ("Assignor"), in favor of MeadWestvaco Texas, L.P., a Texas limited partnership, having a place of business at 501 South 5th Street, Richmond, VA 23219-0501 ("Assignee").

WHEREAS, Assignor has agreed to sell and convey to Assignee, for the consideration and upon the terms set forth in this Trademark Assignment, all right, title and interest in and to the trademarks CAROLINA, ENVIROCOTE and FOMECOTE and the respective registrations and applications therefor listed in Schedule A attached hereto and made a part hereof (collectively the "Trademarks"), and any and all good will associated with such Trademarks.

NOW, THEREFORE, for one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee do hereby agree as follows:

1. Assignor does hereby irrevocably assign, transfer, convey and deliver to Assignee, its successors and assigns, the entire right, title and interest, throughout the world, whether statutory or at common law, in and to the Trademarks, together with (a) all the goodwill of the business symbolized by the Trademarks in the United States and all countries throughout the world, (b) the right to sue and collect damages and/or profits for past and future infringements of the Trademarks and (c) all rights to proceeds, including, without limitation, income, payments, claims and damages, whether presently existing or hereafter arising out of or related to the Trademarks.

2. Assignor hereby acknowledges and agrees that from and after the date hereof, Assignee shall be the sole and exclusive owner of the Trademarks. Assignor further authorizes the appropriate authority or authorities whose duty it is to record trademark registrations, applications and title thereto, to record the Trademarks and title thereto as the property of Assignee, its successors and assigns in accordance with the terms of this Agreement and at Assignee's expense.

3. At Assignee's request, Assignor further agrees to execute any and all documents necessary or desirable to properly vest full right, title and interest in and to the Trademarks throughout the world in the name of Assignee, its successors and assigns, and to perform any other reasonable acts at Assignee's expense generally necessary for Assignee to obtain, maintain, issue or enforce the Trademarks.

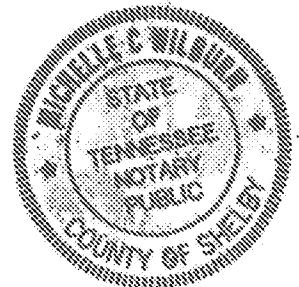

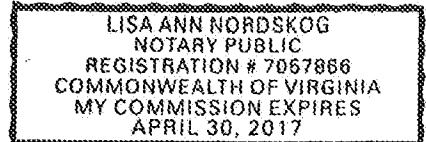
