

FIRST: That this corporation owns all of the outstanding shares of Input

SECOND: That this corporation, by the following resolutions of its Board of
Directors, duly adopted by an action by unanimous written consent pursuant to Section 141(f) of
the General Corporation Law of the State of Delaware on the 31st day of July, 1998, determined
to merge Input Software, Inc. into itself on the terms and conditions set forth in such resolutions:

RESOLVED that Input Software, Inc. be merged with and
into the Company and that the Company be the surviving
corporation in such merger.

FURTHER RESOLVED that the merger shall become
effective upon the date and time of the filing of a Certificate of

Ownership and Merger with a Secretary of State of the State of Delaware.


FURTHER RESOLVED that upon the effectiveness of the merger, the Company shall assume all of the liabilities and obligations of Input Software, Inc.


