SECURITY INTEREST IN TRADEMARKS**

WHEREAS **AMSCAN HOLDINGS, INC.**, a Delaware corporation with principal offices at 80 Grasslands Road, Elmsford, NY 10523, **AMSCAN, INC.**, a New York corporation with principal offices at 80 Grasslands Road, Elmsford, NY 10523, **AM-SOURCE, INC.**, a Rhode Island limited liability company with principal offices at 80 Grasslands Road, Elmsford, NY 10523, **ANAGRAM INTERNATIONAL, INC.**, a Minnesota corporation with principal offices at 7700 Anagram Drive, Eden Prairie, MN 55344, **FACTORY CARD & PARTY OUTLET CORP.**, a Delaware corporation with principal offices at 25 Green Pond Road, Rockaway, NJ 07866, **FACTORY CARD OUTLET OF AMERICA LTD.**, an Illinois corporation principal offices at 25 Green Pond Road, Rockaway, NJ 07866, **GAGS AND GAMES, INC.**, a Michigan corporation with principal offices at 35901 Veronica, Livonia, MI 48150, **PA ACQUISITION CORP.** (successor-in-interest to Party Concepts, Inc.), a Delaware corporation with principal offices at 25 Green Pond Road, Rockaway, NJ 07866, **PARTY CITY CORPORATION**, a Delaware corporation with principal offices at 25 Green Pond Road, Rockaway, NJ 07866, **PARTY CITY HOLDINGS INC.**, a Delaware corporation with principal offices at 80 Grasslands Road, Elmsford, NY 07866, **M&D INDUSTRIES, INC.** (f/k/a M&D Balloons, Inc.), a Delaware corporation with principal offices at 80 Grasslands Road, Elmsford, NY 07866, and **TRISAR, INC.**, a California corporation with principal offices at 80 Grasslands Road, Elmsford, NY 07866 (each, a “Grantor” and collectively, the “Grantors”), entered into a certain ABL trademark security agreement dated July 27, 2012 (the “ABL Trademark Security Agreement”) with **DEUTSCHE BANK TRUST COMPANY AMERICAS**, a New York trust company with principal offices at 60 Wall Street, New York, New York 10005 (the “Grantee” or “Collateral Agent”), notice of which was recorded on July 27, 2012 at the United States Patent and Trademark Office at Reel 4830, Frame 0409.

WHEREAS, Grantors granted the Collateral Agent, under the terms of the ABL Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to certain of Grantors’ intellectual property, including without limitation the trademarks listed in **Schedule A** (collectively, the “Trademarks”) and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.




