RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Trademark Release"), is made as of August 19, 2015 ("the Effective Date") by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, a bank organized under the laws of Switzerland, as Collateral Agent (in such capacity, the "Collateral Agent"), in favor of **BUFFETS, INC.**, a Minnesota corporation, located at 1020 Discovery Road, Suite 100, Eagan, MN 55121), **HOMETOWN BUFFET, INC.**, a Minnesota corporation, located at 1020 Discovery Road, Suite 100, Eagan, MN 55121, **RYAN'S RESTAURANT GROUP, INC.**, a South Carolina corporation, located at 1020 Discovery Road, Suite 100, Eagan, MN 55121, and **TAHOE JOE'S, INC.**, a Minnesota corporation, located at 1020 Discovery Road, Suite 100, Eagan, MN 55121 (each a "Grantor" and collectively, the "Grantors"). Unless otherwise defined herein, terms used herein and not defined shall have the meanings provided or provided by reference in the Trademark Security Agreement, dated July 18, 2012, among the Grantors and the Collateral Agent (the "Trademark Security Agreement").

WHEREAS, pursuant to the terms and conditions of the Trademark Security Agreement, each Grantor granted and pledged to the Collateral Agent, its successors and assigns, for the ratable benefit of the Secured Parties, a security interest in all right, title or interest in or to any and all of the following assets and properties then owned or at any time thereafter acquired by such Grantor or in which such Grantor then had or at any time thereafter may have acquired any right title or interest:

- (a) trademarks, service marks, Internet domain names, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office (or any successor office) or any similar offices in any State of the United States or any other country or any political subdivision thereof; and all extensions or renewals thereof, including those listed on Schedule A (the "Trademarks");
- (b) the right to sue or otherwise recover for any and all past, present and future infringements and dilutions thereof,
- (c) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements and dilutions thereof), and
- (d) all other rights of any kind whatsoever accruing thereunder or pertaining thereto, together in each case with the goodwill of the business connected with the use of, and symbolized by, each of the Trademarks and all other similar assets, rights and interests that uniquely reflect or embody such goodwill, provided that

the grant of the security interest hereunder shall not include any application for a Trademark that would be deemed invalidated, canceled or abandoned due to the grant and/or enforcement of such security interest unless and until such time that the grant and/or enforcement of the security interest will not affect the status or validity of such Trademark application or resulting registration.

(collectively, the “Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on July 20, 2012 at Reel 4826/Frame 0208;

WHEREAS, the Grantor has requested that the Agent: (a) terminate and release all liens and security interests of the Collateral Agent in the Trademark Collateral; and (b) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office; and

WHEREAS, the Grantor has satisfied and fulfilled all of its obligations to release the Collateral Agent’s security interest in and to the Trademark Collateral, and the parties seek to make record of the Collateral Agent’s release to the Grantor of any and all of its security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, for itself and on behalf of the Secured Parties, hereby terminates the Trademark Security Agreement, and hereby releases, relinquishes, discharges, cancels, repledges, reassigns and releases any and all security interests it has in and to the Trademark Collateral including, without limitation, those items referred to on Schedule A hereto.


The Collateral Agent hereby agrees to, at the sole expense of the Grantor, duly execute, acknowledge, procure and deliver any further documents necessary under the rules and other applicable laws of the various jurisdictions, and to do such other acts as may be reasonably necessary upon request of the Grantors (or their assignees or designees) to effectuate the release of the security interest contemplated hereby and to confirm this Trademark Release and Grantors’ (or their assignees’) right, title and interest in and to the Trademark Collateral.


This Trademark Release shall be governed by, and construed in accordance with, the laws of the State of New York, without regard to conflicts of law principles thereof.
